Recycling Facilities

Tehama County's landfill and three transfer stations also serve as drop-off stations for recyclables and yard debris. The sites accept metal cans, juice boxes, milk cartons, plastic containers (No. 1- No. 7), scrap metal, glass, mixed paper, newspaper, and corrugated cardboard. The landfill also accepts antifreeze, batteries, used motor oil, and water-based paints at its Antifreeze Batteries Oil and Paint (ABOP) facility during its normal business hours. Curbside recycling service includes metal cans, milk cartons, plastic containers (No. 1 – No. 7), scrap metal, glass, mixed paper, corrugated cardboard, used motor oil, and lawn wastes.

A construction and demolition (C&D) debris ordinance was created for the City of Red Bluff, whereby all C&D and renovation projects at least 5,000 square feet or city-sponsored C&D and renovation projects at least 500 square feet must separate dimensional lumber, concrete, brick, wood waste, scrap metal, roofing materials, and appliances. A reduced rate for yard waste, wood waste, and metal was implemented to encourage segregation. Clean asphalt, concrete, and dirt are also accepted free of charge.

The Tehama County Sanitary Landfill promotes backyard composting through advertisements with local newspapers about composting resources and upcoming workshops. Besides County reuse programs, many independent thrift stores offer Tehama County residents the opportunity to reuse clothing, furniture books and other household items.


Household Hazardous Waste

The TCRBLMA operates two permanent household hazardous waste facilities located at the Tehama County Sanitary Landfill Red Bluff, CA and at Corning Disposal Corning, CA. The Corning facility opened in January 2007 and operates one day per month. An additional permanent household hazardous waste facility is planned to open for north County residents in 2008. The landfill facility operates every Saturday during the summer months and once per month from November through March. Materials accepted at the household hazardous waste facilities include fluorescent lights, transmission fluid, pesticides, fertilizers, oil-based paints, pool and spa chemicals, detergents, acids, bases, old gasoline, kerosene, lead-based paint, creosote, tar, aerosol cans, and small propane

cylinders. In 2005, ninety-four tons of household hazardous waste was transferred from the landfill to appropriate disposal or recycling facilities.
