

### Map Corrections

Nearly all maps show State Route 89 as extending into Lassen Volcanic National Park. This is incorrect in that SR-89 stops at the southern (in Tehama County) and northern (in Shasta County) boundaries of park. The roadway that travels through the park is titled *Lassen Volcanic National Park Highway*. This is an important distinction in that no state or county funds are used to manage and maintain that portion of roadway within the park.

Map Figure 6-1 in the Background document can serve as a good example of an acceptable way to map the road.
